FOLLOWING CAREFUL REVIEW AND DELIBERATION OF YOUR RECORD AND INTERVIEW, THIS PANEL CONCLUDES THAT DISCRETIONARY RELEASE IS NOT PRESENTLY WARRANTED DUE TO CONCERN FOR THE PUBLIC SAFETY AND WELFARE.

THE FOLLOWING FACTORS WERE PROPERLY WEIGHED AND CONSIDERED.

YOUR INSTANT OFFENSE IN ROCKLAND COUNTY, IN OCTOBER 1980, INVOLVED YOU AND A CO-DEFENDANT ATTACKING A 16 YEAR OLD FEMALE WHICH RESULTED IN HER DEATH.

YOUR CRIMINAL HISTORY INDICATES YOU WERE ON PAROLE AT THE TIME LESS THAN 19 MONTHS FROM A 1978 CRIMINAL SALE CONTROLLED SUBSTANCE 3RD.

YOUR INSTITUTIONAL PROGRAMMING INDICATES PROGRESS WHICH AS NOTED TO YOUR CREDIT. YOUR DISCIPLINARY RECORD REFLECTS FIVE TIER II AND TWO TIER III REPORTS. YOU HAVE SERVED SHU TIME.

BASED ON REQUIRED FACTORS IN THE FILE CONSIDERED, DISCRETIONARY RELEASE, AT THIS TIME, IS NOT CONSISTENT WITH THE PUBLIC SAFETY AND WELFARE.

YOUR DISCRETIONARY RELEASE, AT THIS TIME, WOULD NOT BE COMPATIBLE WITH THE WELFARE OF SOCIETY AT LARGE, AND WOULD TEND TO DEPRECATE
